### First Summer Workshop Held in Monroe, NC

- The first NCNA Summer Workshop was held on July 26, 2008 hosted by South Piedmont Community College in Monroe, NC. Before the regular program began, The Honorable Hunt Gwyn, District Court Judge, 20th-B District, installed Judy Chapman as NCNA's first Legislative Envoy.
- The Honorable Wayne Rash, Caldwell County Register of Deeds, was on hand to give an update on recent legislation affecting eNotarization and eRecording.
- Bob Gannon of Simplifile, an Approved eNotary Solution Provider, demonstrated to the attendees how his company's system makes it possible to notarize and eRecord an instrument instantly. (Mr. Gannon will be a presenter at the September 13th Annual Fall Conference as well and will demonstrate his company's systems in more depth.)
- A panel consisting of accountants, attorneys, paralegals, car dealers, and health care employees were also on hand to talk about their experiences in performing notary acts in their various professions. The name of the Session was called "Expectations of a Notary". The discussions by the panel members were very informative. The audience learned a great deal about several common types of documents (Wills, Powers of Attorney, Healthcare Documents, DMV, and the transfer of real property) and how they are executed and notarized properly.
- The afternoon session was reserved for an eNotary Class taught by NCNA's own Legislative Envoy, Judy Chapman, Notary Public Instructor for South Piedmont Community College.
- All in all, a great day. Thanks to Judy Chapman and Geri Duncan of South Piedmont C. C. for coordinating the event.

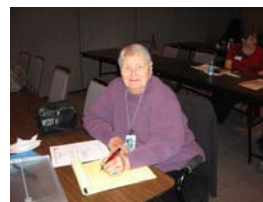
