Mr. Moran explained the role of the Securities Division and invited everyone to call the Division at 800-688-4507 with any questions or concerns. #### N. C. Notary Public—Fact or Fiction

Let's see how well you know the N. C. Notary Act. Listed below are statements related to how a notary can perform an act in North Carolina. Some of them are Fact...and some are Fiction. Test your knowledge of the laws that govern notaries public in North Carolina and check either fact or fiction after the statement. - It is acceptable to notarize any documents for your spouse regarding real property that is owned together by you and your spouse.

- 2. The statutory fee that you may charge for a notarial service is \$5.00 per signature. [] Fact [] Fiction
- 3. Your commission can be revoked if you refuse to notarize a document. [] Fact [] Fiction
- 4. A notary public in N.C. is authorized to certify a true copy. [] Fact [] Fiction
- 5. As a N. C. Notary Public, you are allowed to travel outside the state's boundaries to perform a notary act. [] Fact [] Fiction
- 6. The N. C. Notary's term of office is 5 years. [] Fact [] Fiction
- The N. C. Notary's seal, signature, and notarial certificate must appear on the same page of a notarized document.

- 8. A non-attorney notary is authorized to engage in the practice of law in North Carolina. [] Fact [] Fiction
- A Notary's signature must match the name on the notary's seal, and must match the name in which he or she was commissioned.
